

Article I. Name of the Club

1. Men's Ultimate Club

Article II. Purpose of the Club

1. The Club will provide the University of Arkansas with the opportunity for students and staff to play the sport of Ultimate.
2. The club will provide opportunities for club members to interact and compete with other universities in area tournaments.
3. To promote the sport of Ultimate with a fun, competitive environment.

Article III. Criteria for Membership of the Club

1. The University of Arkansas Men's Ultimate Club shall be open to all students, faculty, staff, and spouses of faculty and staff with a valid UREC membership.
2. In order to be considered a member, prospective members must attend at least 1 practice per week.
3. Removal of Members
 - a. To remove a member from the Men's Ultimate Club, 2/3 of the other members, including the Club President, must vote in favor. The member in question will receive an email informing them of their removal from the club. The removed member will have two weeks to submit a request for appeal and to review why they were removed from the club.

Article IV. Voting Policies for Club Members

1. Members may become voting members in the Men's Ultimate Club if they attend 50% of meetings and practices throughout the whole year.
2. In order to be considered a voting member, members must have paid at least half of their dues:
 - a. Members may also become voting members if 2/3 of the current voting members judge that their opinion and impute is valid and vote that they be able to vote along with the club.

Article V. Duties and Privileges of Membership

1. All members are able to come to practice each week.
2. Tournaments will be on an invite only basis, determined by the club officers and captains.
3. Members have access to all Ultimate materials that the club owns including cones, discs, and other materials as long as they bring the equipment to practices.

Article VI. Description of Officers, their Duties, and Authority

- All officers must attend officer training, officer meetings and at least one Senate Meeting.
1. President- Helps lead practices with help of captains and volunteer coaches. Sends weekend travel emails, car-list and practice reminders. Completes End-of-Semester reports for the club. Oversees all of the actions of meetings and officers to make sure they are completed correctly.
 2. Vice President- Select's tournaments for the club to attend. Provides tournament travel dates well in advance so members can attend. Completes USA Ultimate roster by the announced deadline for the College Series. Completes pre-post tournament meetings with the treasurer. In charge on 3v3 tournament, and other recruiting events.
 3. Treasurer- Keeps track of funds in and outside of HPER. Works with President to complete budget and budget hearing. Completes pre-post tournament meetings with

- vice president. Completes travel advance paperwork and sends it to University Recreation. Picks up and cashes travel advance checks, disperses money to cars, pays post-travel invoices.
4. Secretary- Keeps attendance of members showing up to practices, meetings and tournaments. Submits Monthly Activity Reports and Practice Attendance form to University Recreation. Makes rosters for local recreation leagues, such as FDA's fall league.
 5. Alumni/FDA Relations Chair – Keep in touch with former members and persons associated with the Club. Organize Alumni activities and fundraising events. Attend at least 3 Fayetteville Disc Association meetings and inform team of FDA events.
 6. Harvest Chair - Organize and direct the team with work associated with Harvest Moon Tournament. Includes communicating with the Harvest Tournament director to get a list of task. Attend Harvest related FDA meetings. Duties start late spring, and wrap up mid-November. Represents college interests at FDA events.
 7. Jersey Chair - In charge of facilitating the creation of jersey designs, and ordering/printing jerseys. Also manages team/alumni/FDA orders. Presents multiple options to the officers for final vote

Article VII. Process for Selection of Officers and their Requirements as well as the Process for Removal, and Replacement of any Officer

1. At a time chosen by the majority of the officers, in the middle of the spring semester, returning members will vote on the new officers.
2. Members will nominate others for new officer positions. Nominated members can accept or reject the nomination.
3. Officer positions will then be voted on by present members. The person with majority vote will be the elected officer.
 - a. In the event of a tie, the former President will choose on who will take that position.
4. In the event of an officer leaving the club for specific reasons, the presiding officers will select two replacements for the officer position. The officer position will then be selected through a 2/3 vote by the members of the club.

Article VIII. Process for Selection of Captains

1. During the end of the spring semester, a Captains Poll will be held among the team to nominate members who they feel will be successful captains.
2. The Men's Ultimate Club will have two captains every year selected by the members and officers of the club.
3. Members will then vote on captain nominees. A majority vote of members for two of the nominees will be selected as captains of the team.

Article IV. Process for Selection of Volunteers as well as their Process for Removal

1. Volunteers will be invited to practices by the club President
2. Volunteers will be chosen on by a vote between the club officers
3. In order for the volunteer to be removed there must be a unanimous vote between the club officers, or a 2/3 vote between all team members.

Article X. Club Meetings

1. Club meetings will be held by the officers three times a semester at the President's discretion.

2. At least one weeks' notice will be given by the President of the Club to all members before the meeting can be conducted.

Article XI. Membership Dues

1. Members are required to pay dues in order to travel with the club. If dues from the fall semester have not been collected by the spring semester, then that member will not be able to travel until all dues have been paid.
2. Members are required to pay dues to USA Ultimate in order to play in USAU sanctioned tournaments and the college series.
3. If a member is to leave the club, dues will be nonrefundable from the club.

Article XII. Club Process for Decision Making (Include Quorum)

1. All decisions will be made through the officers.
2. At least half of the club's officers are required in order to take a vote.
3. A vote will be made by all officers; the majority will rule the decision.

Article XIII. Requirements for Selection, Removal, and Replacement of Volunteers and Faculty Staff Advisors

1. Selection, removal, and replacement of volunteers and faculty staff advisors will be done by the officers. At least ½ of the officers' vote is needed to select, remove, or replace a volunteer.

Article XIV Changing, Removing, or amending the constitution

1. A potential change to the Constitution may be brought up by any member of the club. The member must submit why he would like to change the constitution to the team one week prior to the club meeting. After 1 week, a vote will be held with all members. A 2/3 majority vote of the members is necessary to amend to constitution.
2. Any member who is present at club meetings is able to submit a change to the constitution.

Article XV Statement of Ratification

1. We the officers of the University of Arkansas Men's Ultimate Club agree to the above amendments in the University of Arkansas Men's Ultimate Club.
