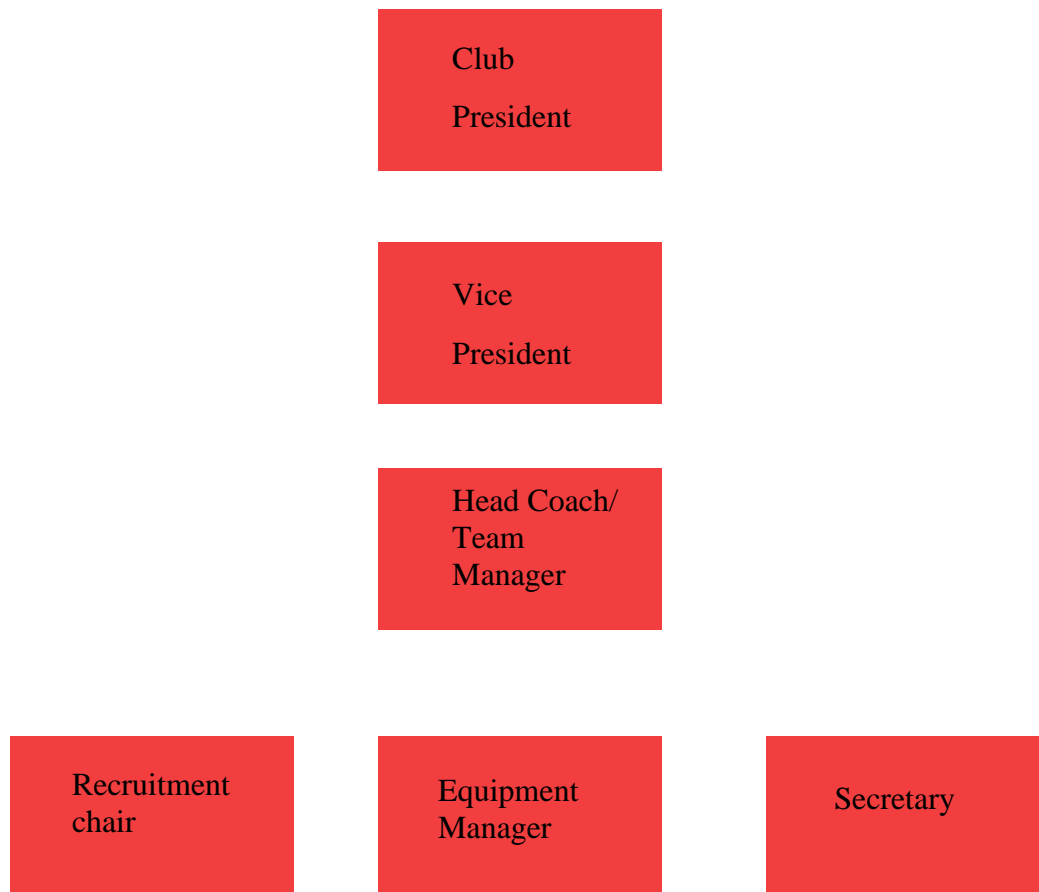


# 2019-2020 Men's Lacrosse Constitution

## Officer Descriptions

## Club President

1. To conduct at least one team meeting every semester
2. Attend annual conference meeting of MCLA (Current conference LSA, Lone Star Alliance)
3. To coordinate and encourage the effective discharge of duties by the other elected club officers;
4. To appoint special committees when these are deemed necessary;
5. In conjunction and coordination with the faculty advisor, to be the official club representative to other agencies and groups of the university community;
6. Coordinating Officer meetings every 2 weeks outside of weekly practice meetings
7. Removal of other Officers with consideration of Head Coach and other Officers

## Vice President

1. To handle all travel request and travel rosters
2. Meet with Club Sports travel coordinator
3. Organize and plan travel and lead travel
4. Coordinate with Head Coach/ Team manager for Hotel and Transportation
5. Turn in all documents for travel on time
6. Keep track of all travel expenses
7. Help present budget with Club President at end of year presentation

## Equipment Manager

1. Equipment – responsible for purchasing and keeping track of all equipment, including but not limited to balls, pads, cones, team apparel, etc; Expenses
2. Place purchases on time and pick up gear ordered to club sport offices
3. Purchase new equipment as needed throughout the year

## Recruitment Chair

1. Establish recruiting regions for all states bordering Arkansas to give incentive towards instate tuition;
2. Giving New players a quick orientation to the club including officers and assisting in getting personal information to Vice President

3. Reaching out to players on campus and off campus about joining the team and meeting with them to build relationship and give information
4. Attend T99 Recruiting event in the Summer to reach high school players and potential future club members

## Secretary

1. Attend meetings, OG and compass.
2. Record attendance at all meetings.
3. Keep record of documents and help with budget presentation
4. Help set up fundraising events

## Bylaws

1. Attendance is mandatory to all scheduled practices and meetings. missing of practices or meetings without a valid excuse will result in suspension of play time in games and in extreme circumstances removal from club
  - 1 missed practice sit out a half.
  - 2 missed practices sit out a game and remediation with officers and captains.
  - 3 missed practices possible removal from club.
  - players must attend all games even if suspended from game time
2. Players must pay \$30 equipment fee when receiving practice gear to cover up front cost.
3. Players must attend all travel events.
4. All dues must be paid by October 15<sup>th</sup>
  - \$2000 for Freshman/New players
  - \$1500 for returning players
  - All dues are non-refundable once paid
