

University of Arkansas Club Golf  
Team Constitution  
August 2021

Article I: Name:  
This organization shall be known as the University of Arkansas Club Golf Team.

Article II: Purpose:  
We, as students at the University of Arkansas, in order to promote interest and participation in the sport of golf through training and competition do hereby establish the University of Arkansas Club Golf (UACG) team.

Article III: Affiliations:  
The club currently is affiliated with the department of University Recreation (UREC), the Club Sports program at the University of Arkansas, and the National Collegiate Club Golf Association (NCCGA).

Article IV: Membership:

- I. Membership in this club shall be determined through qualifying rounds. The organization we have joined (NCCGA) is a men's and women's league.
- II. Qualifying will be open to any student at the University of Arkansas with at least twelve credit hours per semester (six for graduate students) who has not lost his amateur status. If a player has lost his amateur status, he must be reinstated by the United States Golf Association (USGA) before competing in any events.
- III. If more than 16 students submit qualifying rounds, there will be cuts made with those with the 16 lowest scores being offered a spot on the team.
- IV. Those who qualify for the tournaments will become members of the club (16-person team maximum) for the semester and will remain in the club (for the semester) if they are in good standing with the University of Arkansas, the Club Sports program, and pay club dues of \$325 (subject to change with the number of regional tournaments offered) which cover one semester.
  - i. If all 16 students who qualified for the team do not pay dues, then the students with the next lowest scores will be contacted with an offer to join the team and pay dues until there are 16 students on the team in total.

Article V: Executive Board:

- I. President, Vice President, Treasurer
- II. Presidential Duties:
  - a. Preside over all club meetings
  - b. Coordinate and encourage activities of other members and officers
  - c. Sign all purchase requests
  - d. Coordinate the scheduling of tournaments
  - e. Assign Vice-Presidential Duties

Vice Presidential Duties

- a. Preside over meetings with or in the absence of the President
- b. Assist with the Presidential duties
- c. Serve as the President in the event that the President's office is vacated
- d. Record the minutes of meetings
- e. Keep attendance records for meetings and practices
- f. Keep all fiscal records
- g. Serve as the financial liaison with the UREC program and staff

#### Treasurer Duties

- a. Organize fundraising activities (profit sharing or otherwise) once a month
- b. Attend all Officer trainings
- c. Keep track of funds in and outside of UREC
- d. Manage jersey orders and collection of funds for the team
- e. Serve as an assistant to President and Vice President

#### Article VI: Elections:

- I. At the End of the Year Meeting, returning members will vote on the new officers.
- II. Members will nominate others for new officer positions. Nominated members can accept or reject the nomination.
- III. Officer positions will then be voted on by present members. The person with majority vote will be the elected officer.
- IV. In the event of a tie, the former President will choose on who will take that position.
- V. In the event of an officer leaving the club for specific reasons, the presiding officers will select two replacements for the officer position. The officer position will then be selected through a 2/3 vote by the members of the club.

#### Article VII: Meetings:

- I. The UACG is to have two stated meetings per semester, excluding the summer semester when the club is considered dormant.
- II. The President will call meetings seven calendar days prior to the meeting and each player is required to attend. Exceptions can be made in certain circumstances.

#### Article VIII: Funds:

The allocation of club funds will go toward League Fees.

#### Refunds:

There will be no refunds to players once they have committed to a semester on the team.

#### Article IX: Coach:

The President of the club will act as the Coach for the team.

Article X: Amendments:  
Amendments can be proposed by any member and shall be written by the member. The amendments will then be voted on by all members. If accepted by a majority (8 votes) of the club members, preceding Constitution will be amended and ratified.

Article XI: Ratification:  
This Constitution shall supersede any previous Constitutions of any University of Arkansas Men's Golf club and shall go into effect immediately upon a majority vote of the club members ONLY.
